

### THE JOURNEY SO FAR ...

CECOEDECON was founded by a small group of young, committed social workers to provide immediate relief to the victims of devastating floods in Jaipur district of Rajasthan in 1982. From this modest beginning, the organization has evolved, from a needs-based approach to rights-based approach, into a civil society organization focusing on economic justice, livelihood security, basic rights, institution development and civil society building, underpinned by integrated participatory development. Target communities are smallholder farmers, landless poor, women, youth, children, and tribals with gender sensitivity as cross-cutting. Geographical presence has expanded to 15 districts across Rajasthan and Madhya Pradesh.

Interventions aim for community empowerment and self reliance and range from Natural Resource Management, Sustainable Rural Livelihoods, Climate Change, Fair Trade, Disaster Management, Seed Sovereignty, Land Rights, Health, Nutrition, Education and Human Rights. The organization has consistently partnered with and strengthened various stakeholders of the development process such as government, research and academic institutions, judiciary, media, civil society networks, etc.

Over time, CECOEDECON has built up on its grassroots activities by promoting lobbying and advocacy at local, state and national level and establishing strong micro-macro linkages. It is now actively engaged in UN global deliberations on sustainable development and climate change to inform and influence global policies to be people-centric. CECOEDECON's holistic approach within the rights-based paradigm makes it a strong force among Indian civil society and a recognized name regionally and internationally.

### **FOREWORD**

Despite the rapid developments taking place in this technology driven era, the global community is still struggling with the resolution of old grassroots challenges of poverty and inequality, while also grappling with contemporary challenges of deteriorating air quality, climate change induced concerns, growing conflicts and migratory flows. We present this report in the light of the rapid national and global developments to show our solidarity to the development actors worldwide and to reinforce our belief in the immense energy and potential at the grassroots.

The Paris Agreement which only entered into force recently is already facing hurdles at the global policy landscape with US President Trump finally announcing the withdrawal of a key stakeholder from the Paris Climate, Accord undermining the long and intensive process which brought all the nations together to combat the existential crisis of climate change.

On the SDGs front the official Voluntary National Review (VNR) report presented by India extolled on its rapid economic growth and the government's various schemes and programmes being implemented to achieve the core objectives of the SDGs. The official presentation gave no credence to the fact that India slipped 1 point and ranked 131 among 188 nations in human development despite the plethora of government led campaigns. The undermining of this and other reports which are indicating that the grassroots challenges are not being served well by the ongoing efforts is highly concerning. The worsening inequality stats, lack of prioritization of efforts to reduce environmental impacts and the highly concerning situation on women's security are facts the country cannot hide from.

Although the Civil Society has been calling for out of the box solutions and greater commitment of nations towards the global challenges, the slow paced efforts and insensitivity towards accountable, inclusive and just processes are impeding the actualization of the verbal commitments. It is crucial for us to collective work on removing these initial roadblocks and focus on the realization of the goals we have set for ourselves.

India's importance in the region and globally has never been more important. It is being projected as a leader on the climate change front and is also considered to be crucial for the global achievement of the SDGs. The country still has a long way to go to ensure that the hopes of so many actors and stakeholders is not misplaced. While keeping our beliefs in the country's potential strong it is also important for us to accept the apparent challenges and work together towards their resolution. The lack of coordinated actions at the political arena does not lay out the right ideals for the other spheres in the country. The spillovers of this discord are alarming for the social harmony of our diverse and vibrant nation. It is high time that our politicians renounce their politically driven agendas and start leading in the true sense. The need for urgent support to revive the rural economies, fighting inequalities and addressing the security and safety concerns of women should take precedence over all selfish interests.

During this year, CECOEDECON has been working hard to support its partner communities to cope with the rapid changes at various levels. It has continued its engagements with all relevant stakeholders to take collaborative efforts for the welfare of the poor and vulnerable groups.

The organization strives to evolve with the changing context both to serve the needs of its partner community and to meaningfully engage with the wider development audience. The year was another strong example of the commitment of the organization and its team to champion the cause of the marginalized and excluded groups. The reporting period also witnessed a strong step forward by the organization to create a conducive environment to enable our women partners to evolve into change makers in their own right, giving energy to our grassroots efforts. The growing strength of the institutions has been a powerful motivating force reinforcing CECOEDECON stance on local ownership being the lynchpin of sustainability.

I take great pleasure in thanking all the well-wishers, friends and partners of CECOEDECON for your continued support and would like to share the annual report of this dynamic organization for the year 2017-18.

### **UPDATES, CURRENT AND NEW INITIATIVES**

### PARTICIPATION AND ENGAGEMENT AT INTERNATIONAL PLATFORMS

### **Convention of Sundarbans Ecosystem**

The Sundarbans are listed in the UNESCO heritage list as: The Sundarbans and Sundarbans National Park, respectively. The rich flora and fauna has been devastated due to change in climate and human activities. Although hunting and poaching in the area has been strictly banned the ecosystem has been traumatised.

To save the ecosystem from the changes caused due to climate change and human intervention a Convention of Sunrbans Ecosysytem was organised in Dhaka on April 8-9, 2017 by Bangladesh Rural Advancement Committee (BRAC), Bangladesh. Mr. Soumya Dutta a representative of MAUSAM/BCPH was among the key note speakers. He shared his expertise on alternative energy plan for Bangladesh. He was vastly covered by the Bangladesh print and visual media.

### **Of Sugar-coated VNRs and National Realities**

The United Nations-High level political forum on sustainable development was organised from 10 to 15 July, 2017 at

New York. A delegation of Beyond Copenhagen including Ms. Aparna Sahay, Mr. Sharad Joshi, Mr. Ajay K Jha, Ms. Vibhuti Joshi and Ms. Charu Joshi attended the UN HLPF in New York during 10th to 15th July. CECOEDECON, Beyond Copenhagen, PAIRVI, in collaboration with Asia Pacific Regional CSOs Engagement Mechanism (APRCEM) organized a side event on 12th July 2017 titled "Of Sugarcoated VNRs and National Realities". CSO's from 15 other nations shared their views and expertise on the platform. Mr. Ajay K Jha also moderated an APRCEM side event on 'Means of Implementation' on 14th July. The delegation members also helped in the drafting of the statement on Ministerial Declaration.



### **European Commission Framework Partnership Consultation**

The European Union (EU) organized a consultation meet from July 6-7, 2017 in Brussels. The Consultation discussed ways and means to strengthen the political partnership of EU with the CSOs partners and local government. Mr. Ajay K Jha represented he organisation and participated on behalf of the Asia Pacific Research Network (APRN), a framework partner with EU. 28 other CSO partners also participated and discussed New European Consensus, partnership with Africa and Asia, and EU thematic programs among others.

### **Engaging Multiple Perspectives; Creating a Seat at the table**

An expert group meeting was organized by Environment and Development Department (EDD) of the UN Economic and Social Commission for Asia and the Pacific (ESCAP). The meeting was organized at Bangkok from 23 to 25 August, 2017 in order to discuss and measure the quality of community's engagement on the agenda 2030.

Mr. Ajay K Jha represented CECOEDECON, PAIRVI and BCPH at the event. He provided a future road map for engaging CSO's in the agenda 2030 in Asia and pacific along with several interventions. Participants included representatives from other CSOs, country representatives, academicians, EDD department staff and International Association for Public Participation (IAP2) Australia. The issue of community engagement along with CSO's as agents was raised by the participants in sync with the agenda 2030 which says that, 'public participation needs to be ensured in political decision making and does not look at people and communities as a passive recipient of development agenda.'

### **MCED 7 and Ministerial Summit on Environment**

The Ministerial Conference on Environment and Development (organized by ESCAP) and 2nd Conference for Ministers and High officials of Environment (organized by UN Environment, formerly UNEP) on a Resource Efficient and Pollution Free Planet was organized at Bangkok from September 3-5, 2017. Mr. Ajay K Jha and Ms. Vibhuti represented CECOEDECON, PAIRVI and BCPH at the meeting.

The CSO Forum was supported by UN Environment, ESCAP, KAS and APWLD which brought together 60 representatives from Asia Pacific and beyond. UN Environment was also keen to have a draft Ministerial Declaration

which will be discussed and adopted at UN Environmental Assembly (UNEA3).

Mr. Ajya Jha and Ms. Vibhuti Joshi represented CECOEDECON and APRCEM. Mr. Jha contributed in drafting the CSOs collective statement for the Summit. A presentation was made to reflect the Draft Report of the UN Environment and highlight the absence of polluter pays principle, CBDR\_RC, principle of intergenerational equity, and lack of substantive language on business regulation, concerns of the fish workers with industrial fishing, peoples struggles with thermal and nuclear power points and undue emphasis on electric cars as solutions to air pollution. Mr. Jha and Ms. Joshi delivered two collective statements on progress on resource efficiency and pollution free planet. They curated and edited at least 10 constituency statements delivered by Farmers, IPs, Youth and Children, Gender constituencies.



### Building alliances to achieve gender equality and empower rural women and girls

The sixty-second session of the Commission on the Status of Women took place at the United Nations Headquarters in New York from 12 to 23 March 2018. The Representatives of Member States, UN entities, and ECOSOC-accredited non-governmental organizations (NGOs) from all regions of the world attended the session. Ms. Vibhuti Joshi represented CECOEDECON and Beyond Copenhagen at the forum and shared her views on, 'Challenges and opportunities in achieving gender equality and the empowerment of rural women and girls'.

On the occasion she emphasised on the increasing gulf in the access to resources which is accelerated by rampant privatisation, making the women more vulnerable. An urge was made to the member states to develop a political will to assess and support the basic development needs of the rural women.

She also raised the distress of the shrinking space for the CSOs, civic participation and right to democratic dissent, at all levels of engagements.

### Rural women at the core of effective climate change response

CECOEDECON, Beyond Copenhagen Collective (BCPH) and PAIRVI, organized a side event on the subject of climate just and just transition during the 62<sup>nd</sup> session of the United Nations Commission on the Status of Women in New York on March 14, 2018. The event titled- 'Rural women at the core of effective climate change response', was held at The Armenian Convention Center, Guild Hall. The event aimed to look at the subjects of climate justice and just transition from a gender purview. Ms. Mariam Diallo, Ms. Natalie Kostus and Ms. Vibhuti Joshi were the keynote speakers.

The speakers suggested that a change in cultural practices and better infrastructure can help the girls have a better future. They also emphasized the need for a strong implementation mechanism for the Paris agreement, while highlighting issues of climate finance and role of private companies towards women rights. The discussion also focused on the linkage between energy and gender explaining that any stress on surrounding ecosystems, climatic or otherwise, is likely to render the poor and vulnerable women increasingly vulnerable to energy scarcities.

### Making Paris Agreement Work: Enhancing the Transparency of Actions and the Place of Climate Finance



CECOEDECON, Beyond Copenhagen, and PAIRVI organized a side event titled "Making Paris Agreement Work: Enhancing the Transparency of Actions and The Place of Climate Finance" during the 23rd session of the UNFCCC's CoP in collaboration with PACJA, CUTS International on 8th November, 2017 in Bonn, Germany. The event looked at multidimensional aspects of climate finance through inputs from CSO's, Multilateral Development banks, Regional cooperation organization and academicians.

The discussion revolved around the gaps in climate finance. Mr. Mithica Muanda from PACJA suggested that finance is required to support adaptation, mitigation and innovation in developing nations. Ms. Loius from African Development Bank (ADB) showcased the problems of African Nations. Mr. Ajay K Jha raised the issue of proper allocation of funds in developing nation and rise of private interference with changing priorities of banks in the region. Dr. Jhonson from the Economic Committee of West African States (ECOWAS) highlighted the issues reflected in the NDCs of the member countries.

### **Just Transition to a Low Carbon and Sustainable Future**

To discuss on a key question in the climate debate around the guiding principle to achieve just transition CECOEDECON along with PAIRVI and Beyond Copenhagen organised an event titled in Just Transition to a Low

Carbon and Sustainable Future. The event was held in collaboration with ITUC Africa, Center for Energy, Ecology and Development, MISEREOR, Friedrich Ebrt Stiftung and Coastal development partnership during UNFCCC COP 23 on 15th November, 2017 at an event organised by, in collaboration with.

In the discussion it was stressed that energy systems require good governance to succeed. Good energy is also at the centre of development needs and priorities thus, high standards of human rights and sustainability are crucial in generation, access as well as affordability aspects. The availability of low cost renewable energy resources is also a concern, in the event it was discussed that low cost solar and wind energy could solve the problem, but the intense private intervention is a matter of concern. The panellists were of the opinion that universal



standardisation of carbon emission can't be a solution as national actions are more important than universal standards.

### Will We Have Paris Without Pre 2020 Actions

**Continuing the engagement efforts** CECOEDECON, PAIRVI and BCPH organised a side event titled "Will We Have Paris Without Pre 2020 Actions" at the Indian Pavilion during CoP 23on November 15, 2017. Hon'ble Minister of Environment, Forest and Climate Change, Mr. Harshwardhan was also present during the event. He eloquently underlined the Indian traditional practices on production and consumption and the Indian way of life as solution to the climate crisis.

The speakers discussed that emission and adaptation gap should be at the centre of the climate negotiations. They stated that India's leadership must be recognised going beyond the talk shop nature of the climate discussions and talking about clear guidelines. Mr. Atul Kumar Anjan, senior CPI leader, raised the call for developed countries to also take accountability of their contribution to the climate crisis due to the wars they have waged in different parts of the world especially in central Asia. Mr. Sanjay Paswan, former Minister of India, suggested the compiling of a compendium of good practices and experiences from different parts of the world on local solutions and people led innovations which can be widely circulated and can help in the efforts to reach out to people of not just the developing but also the developed countries.

### 53rd Global Environment Facility (GEF) Council Meeting on November 25-30, 2017 at Washington DC

Mr. Sharad Joshi attended the 53rd Global Environment Facility (GEF) Council and GEF Council consultations with civil society organizations held at the Preston Auditorium, World Bank. He was sponsored as one of the CSO's representatives. The guidelines on inclusive and gender sensitive processes were discussed during the meeting. The meeting was an important opportunity to understand GEF's policy and engage in processes to ensure greater inclusiveness through collaborative efforts and continuous engagement.



### Third UN Environment Assembly (UNEA3) in Nairobi, Kenya on 5th Dec., 2017

Mr. Ajay K Jha participated (representing CECOEDECON/APRCEM) in the UNEA 3 (as a fully funded participant), which was held at UNEP headquarters in Nairobi during 27<sup>th</sup> November to 6<sup>th</sup> December. The theme of the UNEA being Towards a Pollution free Planet; UNEA adopted 11 resolutions, including containing marine plastic litter, improving air quality, containing exposure to led paint, address water pollution and soil pollution, and address pollution in areas affected by terrorism and armed conflict, and a Ministerial Declaration. However, it evinced undue reliance on business and industries for finances and solutions to prevent pollution. During the GMGSF (Global Major Groups and Stakeholders Forum)



which was organized by the APRCEM on 2<sup>nd</sup> and 3<sup>rd</sup> December at UN Campus Nairobi, Mr. Ajay K Jha, chaired a panel discussion on Air Pollution, the panelists included YuyunIsmawati, Bali Fokus, Indonesia, Mithika Mwenda, PACJA, Kenya, and Sam Barratt, Chief of Public Advocacy, UN Environment. During the UNEA, Ajay also moderated a side event on "Impact of Pesticides on Communities" organized by PAN AP Mr. Ajay Jha also delivered a collective statement from the farmers constituency and led the drafting team for the outcome statement of the GMGSF.

### Partners of APSD are organizing side events at APFSD (Asia Pacific Forum on Sustainable Development) (March 25-30, in Bangkok)

Mr. Ajay K Jha represented CECOEDECON in the Asia Pacific Forum on Sustainable Development (APFSD, 28<sup>th</sup> to 30<sup>th</sup> March) organized by the UNESCAP and Peoples Summit, preceding the APFSD to provide input to the APFSD and organized by the APRCEM and the ESCAP on 25<sup>th</sup> to 27<sup>th</sup> March. During the APFSD Mr. Ajay K Jha was a panelist on Goal 12 (Sustainable and Consumption and Production) organized by UNESCAP along with Minister from Bhutan and Chair of the Switch-Asia, who were the other panelists. During the Peoples Summit at the Chulaonkorn University, Bangkok, Ajay spoke on the "Probable Impact of the RCEP on Farmers" in a workshop organized by Ibon International. He also curated a number of constituency statement and led the drafting team for the final Peoples Summit outcome statement.



### **NATIONAL LEVEL EVENTS**

### Krishi Vimarsh with Dr. Vandana Shiva

Krishi Vimarsh was organized on August 12, 2017 at CECOEDECON campus in Jaipur with eminent environmentalist Dr. Vandana Shiva. She discussed the concerns of the farmers, and raised questions about the use of pesticides, patent of mustard seeds, import dumping of pulses and the issue of pricing. Later in an interactive session she stressed on the need to face these challenges through non-violent means by adopting local seeds.

She emphasized upon the value chain of organic farming as a tool to production. She stated that organic farming is cost effective and hence should be adopted as the cropping method. She said that yield is a wrong measurement of farm produce; the farm



produce should be measured upon its nutritious inputs. The members of KSS and the present dignitaries took an oath to bring Anna Swaraj (food self-reliance) and promote organic farming. Dr Shiva appreciated the collective campaign against Genetically Modified Seeds initiated by Kisan Sewa Samiti and partner organizations.

### **Challenges and Coping mechanism for Climate Change**

A state consultation meet was organized in collaboration with TATA Trust on September 20, 2017 in Jaipur to identify the challenges of climate change and possible interventions for coping up with the climate induced challenges.

Eminent speakers and environmentalist shared their views on the occasion. Justice V. S. Dave, Chairperson of CECOEDECON emphasised in his inaugural speech on conservation of indigenous knowledge and traditional way of conserving natural resources. Professor M. S. Rathore delivered the keynote address. He stressed upon promoting traditional water harvesting structures. He said that Water scarcity has been a major issue in Rajasthan and there are some areas where even drinking water is being supplied every alternate day. Nearly all the natural sources of water have some mythological origin. In Rajasthan, there are various traditional water source systems, such as kund, johad, bandha, sagar, and sarovar which need to be conserved. Mr. Manish Singh, Director, CECOEDECON



presented an overview of how livelihoods of small and marginal farmers have been affected due to climate change in the state.

Around 40 Participants from various NGOs, government departments and media persons shared their views and collectively identified the priorities for the state in terms of coping up with the climate induced challenges.

### Rally on Act for SDGs at Newai

Act4SDGs is a joint campaign convened by The UN SDG Action Campaign, the , the Global Call to Action against Poverty (GCAP) and Action for Sustainable Development. It calls for organizations and citizens to act on the SDGs on 25th September – a Global Day of Action.

In the process of generating awareness on SDG's among CSO's, CBO's, parliamentarians, media and youth groups CECOEDECON organized a rally in Newai on 23rd of September, 2017. The purpose of the rally was to sensitize the

government towards achieving SDGs by 2030 with an approach of No one left behind. More than 100 farmers, youth, PRI members, Women and youth participated in the rally.

### **Providing insurance to farmers: PMFBY**

CECOEDECON along with Kisan Sewa Samiti organized a one day consultation on PMFBY at its branch office Shilki Dungri on 29th of March.

Additional Advocate General Mr. Shyam Ladrecha tried to hear and provide remedy to the concerns and problems faced by 60 representatives of farmers from 5 blocks. He helped in solving the local issues of farmers like poor land records, flawed land titles, corruption which they face during the crop insurance claim process. He added that the responsibility of the success of the schemes lies on the shoulder of farmers as how sincerely it is implemented and monitored.



### **Food Funchayat: Celebrating food diversity**

CECOEDECON and Kisan Sewa Samiti organized a food festival "Food Funchayat" on 31st December, 2017 at Shilki Dungri, Jaipur. The objective behind organizing the farmers fair was to provide an opportunity to small and marginal farmers and agrarian community, practicing agriculture using local seeds and organic methods, to exchange their seeds, value-added products, agri practices, marketing skills and other experiences.



The event was marked by brainstorming on "Deshaj Khadyan Ka Mahatva" (Importance of Indigenous Food). Mr. S. D. Kabra deliverd the keynote and shared the status of use of pesticide in Punjab. The indigenous food was showcased and cooked by KSS members. Food Funchayat was a celebration of food (traditional food), fun (traditional rituals) and panchayat (discussion on agricultural issues). After having interaction with KSS, participants from other states were very impressed with their initiatives and their coordination with CECOEDECON. It was an attempt to relive and revive the age old traditional cookery and eating practices of different regions. The large participation and involvement of youth showed us path to reinvent indigenous food and practices.

### Dialogue with media on emerging issues

A day long discussion on Climate Change and Sustainable Development Goals was organized with media on March 24, 2018 in Jaisalmer. During the discussion local journalist discussed the local issues related to climate change, agriculture and livelihood of local community. All media persons assured CECOEDECON and KSS, Jaisalmer to support their campaigns, movements and interventions related to public welfare.



The issue of sustainability in agriculture was shared with farmers of Malpura, Tonk in an event organised by CECOEDECON on March

28 by Mr. Leelaram Gurjar, Senior Agriculture Scientist. He shared his experience on proper management of livestock and mix cropping. He emphasized on sustainable agriculture and saving the land form un controlled use of pesticide and insecticides. He also shared information about new schemes related to farmers.

### THEMATIC AREAS AND PROGRAMS


The idea of development for CECOEDECON lies in empowering the marginalized and excluded community by ensuring self-realisation of their needs and eventually self-reliance. The idea lives through major interventions in 5 different thematic areas which serve as the life line of people's development in the area.

A brief on the on goings in these different thematic areas is provided as under:

### **BASIC RIGHTS**


"To consolidate the ongoing empowerment processes and further strengthen the community based mechanisms that support rights based entitlements of the most excluded communities."

The rural communities face challenges stemming from low literacy, lack of awareness about rights based entitlements, access to quality education and health services in the far flung areas which coupled with stringent socioeconomic factors hamper their development potential. CECOEDECON through its Basic Rights programme works on providing support and solution to these problems. The program also takes steps to strengthen democratic institutions and forums at local level, supporting community, women and children in addressing injustice and providing methods for climate change adaptation by being gender sensitive.



### **Educating Tribal Girls at Shahbad**

The right to education provides every child the right to formal education but does not ensure means to achieve it. Understanding the lack of means of girls of tribal communities in Shahbad,CECOEDECON started running a residential school for drop-out girls (with special focus on Sehariya, the primitive tribe of Rajasthan).



### **WAJOOD**

CECOEDECON collaborated with Population Service International (PSI) aimed at achieving gender equality and gender empowerment and reducing harm of gender based violence on women and girls. The focus is on increasing access to related services, improving knowledge and beliefs surrounding negative gender norms thereby improving the environment for the uptake of Gender Based Violence (GBV) and Reproductive Health Services. The project is being implemented in 200 villages of Newai and Chaksu.

CECOEDECON has started counseling centers at Chaksu and Newai under the project. SHG and community leaders have been trained to take active roles in supporting GBV survivors. A mass awareness generation campaign covering 40 Gram Panchayats has also been conducted under the project.




The project is supporting GBV survivors through access to relevant services. Around 700 cases of domestic violence have been registered. Kisan Seva Samiti and SHG federation are main stakeholders of the project. Violence Against Women Fortnight campaign has been conducted in both blocks for 15 days in 30 Gram Panchayats.

### LIVELIHOOD SECURITY AND ECONOMIC JUSTICE

To build climate change adaptation capacity of stakeholders while simultaneously securing the sustainability of livelihoods of the poor and the marginalized."

Economic justice is a part of social justice which can be achieved only if livelihood is ensured. Livelihood security is integral to Economic Justice. In the changing socio economic and political environment, climate change is also a factor. The constant change in climate is forcing large scale migration, loss of crop, emergence of new threats to farming pattern and available resources. In such a scenario, we have tried to develop inclusive development and adaptation plans considering the emerging threats from climate change to ensure sustainable livelihoodsfor the poor and marginalised.




### **Accomplishments**


- ❖ The dissemination of results of a longitudinal study on rainfall variability conducted to understand the relation between agriculture production and rainfall variability helped farmers and women farmers at grassroots understand the trend of the changing climate.
- The farmer community benefited by state level workshop for knowledge sharing on Pradhan Mantri Fasal Bima Yojna. The focus was on understanding and solving problems in accessing the benefits.
- 11 Farmers producer organization have been formed and ave assisted their members to diversify their livelihood sources and earn extra income from these sources.
- 18 girls at Shahabad were also provided training in producing Sanitary napkins under the skill development scheme.

### **Microfinance and Financial Inclusion:**

CECOEDECON microfinance program was started in 1996 to address the lack of access to credit the rural women were facing due to their low social status, lack of control over resources etc. In order to improve this situation, through strengthenng women's economic standing, CECOEDECON promoted micro-enterprise development and encouraged micro-finance. This was done through organization of women into Self Help Groups, enhancing their capacities and facilitating saving among them by opening groupccounts in banks. Eventually, the large base of SHG's called for a higher level of organization and systematic management which led to the formation of Cooperatives. These Multipurpose Cooperative Societies are actively working to ensure financial inclusion, financial literacy, livelihood sustainability and access to credit for the partner community. These efforts have brought about significant changes in the status of the member women, by not just making them financial secure but also contributing to the empowerment and overall development.


### **INSTITUTIONAL DEVELOPMENT**

"To provide facilitation and support to the Apex institutions in sustaining village level institution development processes and further strengthening the village level institutions such as Panchayats, VDCs, youth groups and Women groups, to enhance their active participation in climate change adaption measures that would secure sustainable livelihood of poor and the marginalized."

Community based organizations are vital for the overall development of a community. They act as the harbinger for peoples aspirations and needs in the fore front of policy makers. They also perform as a pressure group, informant group and/or as development group for the voices of people of a community. The organisation has adopted institution building as a core strategy. The groups promoted by CECOEDECON have strong integration, interaction and co-operation which provides strong bottom up approach in identifying and addressing the local needs. CBO's like VDC, KSS, KSSM, Women group, youth group and adolescent group are active in the region providing voices to the needs of the beneficiary.

### **Accomplishments**

- ❖ 55,574 people reached through awareness generation on adaptation practices for climate change.
- 1257 Chaupals organised to hold discussion with local communities on different government schemes and programmes like MGNREGA, social security, health, liveliood, agriculture, horticulture, fisheries, animal husbandry, soil and water conservation and other department schemes that have a great relevance to climate change adaptation measures.
- With the joint collaboration of CBO's and Gram Panchayat the people have raised their concerns in accessing the schemes. They actively participated in various campaign for different schemes like Jal Swawlamban Abhiyan (a state government initiative to conserve and harvest rain water), Rajaswa Lok Adalat Abhiyan (a state government campaign to resolve revenue related cases through public hearings), Gram Sabha organised to formulate Gram Panchayat Development Plan and Pt. Deen Dayal Upadhyay Shivir a government led welfare campaign.



- ❖ Joint capacity enhancement trainings of CBO's and PRI were organised to develop common understanding on issues of development practices and climate change. A synergy was developed to draft Gram Panchayat Plans.
- The CBO's have played an efficient role in ensuring that poor finds its just in the society, No one is left from the cycle of development and benefits from different schemes.
- The implementation of Protection of Women from Domestic Violence (PWDV) Act 2005 was ensured by the CBO's by successfully demanding for the appointment of protection officer supported by the capacity building of Aasha and Sathins.

### **CIVIL SOCIETY BUILDING**

"To facilitate the process of enabling environment for CSO's and CBO's towards advocating sustainable development with specific focus on integrated approach on climate change."

The civil society plays an role in supporting the implementation and monitoring the different aspects of policies and schemes of government. It speaks for the ground level community and acts as a bridge between the government and people's voices. Realizing the importance of building common voices and collaborative efforts, CECOEDECON has taken up Civil Society Building as a key intervention.

The organisation held several events at National and International level under the organisations objective for Civil Society Building (as briefly mentioned in earlier sections). Best examples and practices based on the organisations grassroots experience were also shared through participations at district, state and national level. Some of these include:

- **Consultation on PC&PNDT Act:** SRKPS organized State level consultation on PC&PNDT Act. CECOEDECON participated in the consultation and raised the issues of awareness generation, sensitization of males and education of girls.
- **Workshop on Child Marriage:** In a workshop organized by Plan India and SRKPS on prevention of Child marriage, experiences were shared by CECOEDECON on prevention and successful strategies.
- **CSW Planning Meeting:** At Jaipur on 17th Feb 2018 was attended by CECODECON's Staff.
- **Jan Swastya Abhiyan:** A network has been developed by Prayas for advocacy on better health services in the State. CECOEDECON shared the status of health services in the meetings organized under the campaign.
- Chirali: CECOEDECON organized ToT for trainers with the cooperation of United Nations Population Fund (UNFPA) and Department of Women and Child Development (WCD). Training was organized to train the trainers for capacity building of district and block level officials to form and strengthen Chirali groups to address domestic violence against women. Problems of survivors, loopholes in service delivery mechanisms and needs were shared with the state level authorities.
- Workshop on Building Child Protection Environment n Rajasthan: This workshop was organized by Chetna Gram fund and Child Fund jointly to address the issue of child protection. Grass root problems and local mechanisms were shared at this platform.
- Dissemination Workshop on Wajood: Experiences of working and domestic violence were shared including needs of DV survivors, status of services and recommendations, with state level officials.

These platforms have been fruitful for us as well as the community as they proved to be a knowledge sharing platform which served as a learning forum for CSO's, NGO's, academicians and policy makers.

Along with these specific activities CECOEDECON with partners as part of the BCPH network is taking collaborative efforts being supported by MISEREOR. These interventions are foused on improving adaptation practices, loss reduction and creating and advocating more employment/income opportunities in seven states (Rajasthan, MP, UP, Chattisgarh, Uttarakhand, Maharashtra and Jharkhand).

More than 350 farmer households have been egaged directly. Some of the highlights are presented below

### OTHER PROGRAMMATIC INTERVENTIONS

### Childline, Jaisalmer (Govt. of India)

Area: Jaisalmer District in Rajasthan.

For the past 7 years CECOEDECON is implementing as a collaborating agency for Child India Foundation and


Ministry of Women and Child Development, GOI. The project is directed towards protection of children and their rights through the Helpline number 1098. The special focus is on the children in need of care and protection, especially the more vulnerable sections. CECOEDECON has been working efficiently towards spreading awareness amongst people by conducting Nukkad Natak, lectures and meetings in slum, schools and public places, media and news rally etc.

During the year child Line, Jaisalmer conducted 34 awareness programs for school children and 15 in slums. 510



children and adults were reached through Grass root level outreach with children and concerned adults. Additionally a helpdesk especially setup during the Ramdevra Mela helped in finding 76 missing children.

### BetiBachaoBetiPadhaoProgramme (BBBP) Supported By UNFPA

**Objectives:** In order to improve the Child Sex Ratio and ensure education of girls towards achieving gender equality, a flagship program Beti Bachao Beti Padhao has been launched by the Government of India (GOI). The Goal of the Intervention that is planned under the Work Plan is to strengthen the capacities of the Government and Civil Society

at the District level to enhance the value of the Girl Child. Additionally the focus is also on strengthening the planning, implementation and monitoring processes related to the BBBP at the District level for effective roll out of the BBBP in Sawai Madhopur. Moreover, the program also works on building capacities of various stakeholders on addressing the concerns of declining child sex ratio, various forms of gender based discrimination and on developing effective strategies to address this issue at the District level.



### **KEY OUTCOMES:**

- The reporting period observed focused efforts by the district teams in strengthening institutional mechanisms.
- Right from district to village level BBBP task force meetings were organized.
- Process of developing district plan of action was facilitated by the district teams.
- Concerted efforts have been done for creating rapport with District Legal Service authority.
- District team has facilitated department capacity building interventions for frontline workers i.e. Anganwari workers, ASHA and Sathins. In Karauli trainings of Sathins and Peer educators were organized.
- A training module is being administered with the purpose of inculcating life skills and sharing other information related to reproductive health, relationship building, etc with adolescent girls. As a result some girls have come forward and stopped child marriages in their village.
- An action plan has been developed and by involving different stakeholders various interventions have been started for developing 5 model gram panchayat. Developing girl child friendly schools is the integral component of the program to enhance girls' enrolment in the school. Team is participating in VHSNC, SMC, SDMC meetings and working to strengthen these forums.

### Nai Roshni

Supported by Ministry of Minority Affair, Government of India

Area: Tonk District

The objective of the scheme "Nai Roshni" is to empower and instill confidence among minority women, including their neighbors from other communities living in the same village/locality, by providing knowledge, tools and techniques for interacting with government systems, banks and other institutions at all levels. CECOEDECON has successfully completed trainings of 300 women (during the reporting period) of the Muslim Minority community in Tonk District of Rajasthan under this scheme.



As a result of this intervention:

- Awareness on the issues of health, education sanitation etc. has increased.
- Access to services and schemes increased.
- Women are taking up issues of violence against women raised and approaching legal services.

### **Empowering Elected Women Representative (EWRS)**

Supported by: The Hunger Project

Area: Chaksu, Newai and Shahbad blocks of Rajasthan.

**Objectives**: The project aims at strengthening women leadership at the grass roots level and to enhance capacities by focusing on their leadership and negotiation skills, develop their self-esteem; while also enhancing their awareness about the three tier structures of the Panchayati Raj Institutions (PRIs), the roles and functions of PRIs, and the roles of the EWRs. The intent is to build and facilitate institutions of EWRs at the blocks in order to create a support structure for women representatives. Working with Panchayats to build a more conducive environment for ensuring effective participation of women in the local governance, including policy planning and implementation, is also a priority.

During the reporting period capacity building trainings, Mahila Jagruk Manch (MJM) meetings (at 10 Panchayats in all three blocks) and meeting of 3 block level federations have been organised.



### **Anganwari Workers Training Center (GOI/ICDS)**


Supported by Ministry of Women & Child Development, Government of India

CECOEDECON is running a training centre as part of a project called Systems Strengthening and Nutrition Improvement Project (ISSNIP) under GOI's Integrated Child Development Services (ICDS) department supported by



World Bank. The purpose of the training is to reach out to women in rural areas and urban slums, to educate them on matters of basic health and hygiene, nutrition, pre-natal and post-natal maternal and childcare and child rearing. It also severs the purpose of equipping the beneficiaries with the knowledge of ICDS and its mandate, proper functioning of Anganwari centre, better nutritional care of the children and keeping database.

The detailed information of the trainings and participation during the reporting period is given below:



### **CORPORATE SOCIAL RESPONSIBILITY INITIATIVES IN JAISALMER**

CECOEDECON is working on the following CSR initiatives in 37 villages of Jaisalmer district:

- Project SRIJAN VI in partnership with SUZLON foundation in 34 villages
- Project SUCCESS with SUZLON foundation and China Light & Power (CLP), India in 3 villages

The major objective of these projects is to enhance livelihood of the community through agriculture and livestock development, improvement in infrastructure of schools, improvement in clean drinking water availability, development of water harvesting structures, improvement in sanitation, tree plantation for environment protection, vocational trainings for income generation of women,



electrification of houses, and strengthening of community based institution to take up development issues.

### **Community Leadership Programme (CLP) Gadepan**


We are working in partnership with K.K. Birla Memorial Society under the Community Livelihood Project, the program aims at supporting livelihood enhancement needs of communities living in 8 villages nearby Gadepan (Kota). Specific inputs being provided to the communities include access to safe water and sanitation facilities, training for agriculture and horticulture, animal health, promoting self-help groups (SHGs) and institutional building. Besides, the project has also been instrumental in organizing groups of adolescent girls and providing them training in life skill areas.

### **Collaboration with Grand Circle Foundation**

CECOEDECON is collaborating with the Grand Circle Foundation to provide exposure of Indian rural life and associated challenges to foreign travelers. The initiative is aimed at opening a new avenue of infrastructural support for the rural communities and to ensure exchange of ideas. During the reporting period the intervention has been able to attract an investment of INR 12,07,000 for the infrastructure development at Adarsh Senior Secondary School, Thikariya Gurjaran and Girls Secondary School, Garudwasi. Also the travelers have contributed 75,000 towards the construction of 5 toilets.



### **SATELLITE INSTITUTIONS**

To address issue-specific areas more effectively, CECOEDECON has established off-shoots to its core work areas to move beyond existing interventions:



- **SWARAJ Social Work Academy for Research and Action, Jaipur,** an initiative committed to develop appropriate human resource for social development sector thereby undertaking knowledge management, training, education and research activities.
- PAIRVI Public Advocacy Initiatives for Rights and Values in India, New Delhi, an advocacy support center
  that caters to capacity building needs of social advocates working in ten states in north-central India.
- **BCPH Beyond Copenhagen Collective,** one of CECOEDECON's new initiatives. This pan-Indian coalition of 40-plus organizations addresses emerging issues of climate and environmental justice, energy equity, sustainable development and post-2015 development. It engages with various stakeholders at multiple levels, to bring about desired change in policies and programs.
- **Block-level Women's SHG Federations**, apex institutions of village-level Self Help Groups across five blocks of Jaipur, Tonk and Baran districts; that have been federated to promote economic empowerment of women.
- Sanvardhan Financial Services Pvt. Ltd., apex organization for 'Microfinance' at state level.
- JP Jal Prahari, a specialized network working on water issues in Rajasthan.
- **CDHR Centre for Dalit Human Rights,** an information and support centre on Dalit issues. With focus in Rajasthan, it intends to work with Dalit groups in other north-Indian states as well.
- DCNC Development Coordination Network Committee Trust, a state-level network of NGOs working in Rajasthan.
