

#### THE JOURNEY TILL DATE ...

CECOEDECON was established by a group of young social work professionals in 1982. Starting with immediate relief work to the flood victims in Jaipur district of Rajasthan it moved into rehabilitation and then into long term development initiatives. Initially focused on addressing the immediate needs of the marginalized communities, the organisation gradually shifted its approach to promoting holistic and long term development. The thematic focus extended to broader themes of Economic Justice & Livelihood Security, Basic Rights, Institutional Development and Civil Society Building.

Over the years, the target communities include mainly the small and marginal farmers, landless poor, women, youth, children, tribals and communities vulnerable to the risk of trafficking (Nats). Direct reach of the organisation extends to 10 districts in Rajasthan and two districts in Madhya Pradesh. With the mission of empowering the communities for their self reliance, the interventions range from Natural Resource Management, Promotion of Sustainable Livelihoods, Climate Change, Disaster Management, Sustainable Agriculture, Health, Nutrition, Education, Gender and Child Rights.

The organisation has been able to develop strong Community Based Organisations at the village and block level; and effective partnership with a large number of Civil Society Organizations at the state and national level. The partnership extends to other stakeholders such as the Government, research and academic institutions, judiciary, media etc.

Believing in the micro-macro linkages, CECOEDECON has built upon its grassroots activities by promoting engagements at the state, national, regional and even at the international level. Currently it is actively involved in UN global deliberations on sustainable development and climate change to inform global policies to be people centric. CECOEDECON's holistic approach within the rights-based paradigm makes it a strong force among Indian civil society and a recognized name regionally and internationally.

#### **FOREWORD**

It is my pleasure to introduce CECOEDECON's annual report for the year 2019-20. I would like to thank the Executive Committee for reposing faith in me to lead the organization after the sad demise of its founder Shri. Sharad Joshi, on 23rd December, 2018.

Despite many challenges, 2019-20 was a year in which CECOEDECON made significant progress in all its programs and organizational development processes. The thematic issues such as Livelihood & Economic Justice, Basic Rights (Education, Health, Gender) Institutional Development and Civil Society Building have significantly contributed to the achievement of the objectives of the programs of the organization.

The Livelihood Security theme focussed on enabling the small and marginal farmers to access adequate and sustainable income and resources to meet the

basic needs of food security. In order to enhance the knowledge and skills of the marginalised farmers, various capacity building trainings and exposure trips were undertaken on various innovative, improved and climate resilient agriculture practices. This year particularly the support for various demonstrations for the promotion of 'Smart Agriculture" farms in all the five working blocks resulted not only in increasing the income of the farmers but also helped in promoting sustainable livelihoods. The year also witnessed a considerable number of farmers accessing the benefit of various Government programs related to food security and other income earning opportunities.

Under the Basic Rights theme, education, health and gender issues were taken up with the support of the Community Based Organizations promoted by CECOEDECON. Special attention was paid to enrol the dropped out students, especially the girls to continue their education. More than 242 students were encouraged and supported to appear for the State Open Board Examinations. Residential School for the tribal girls to provide them with 'Second Chance Education' resulted in 53 Shaharia girls appearing for the Board exams. Democratic institutions formed at the village and Panchayat levels for the protection and development of children such as the 'School Management Committee (SMC), Village Child Protection Committee (VCPC), Village Health Sanitation and Nutrition Committee (VHSNC) were activated with the help of the CBOs which has resulted in improving the quality of education and health care services.

The Institution Building' theme witnessed further strengthening of the capacities of the village level institutions and the Apex level bodies. Special efforts were made to build the capacities and interests of the youth involved at the village level. Increasing number of issues taken up by these institutions bear witness to their active involvement in addressing the day to day problems that affect the marginalized communities to whom they belong to. The civil Society building processes have led to better partnership with other CSOs at the state and national level. Climate Change and SDG related issues were taken up collectively with the support of the Civil Society partners at different levels.

The organization's engagement at the international level received further impetus as it participated in the following major events:

United Nations Climate Change Conference (COP25) Madrid Spain; Commission on the Status of Women-CSW63; UNEA 4 and the Global Major Groups and Stakeholders Forum-GMGSF: ASEAN People's Forum/ ASEAN Civil Society Conference and Regional Training of Trainers on Advocacy and Engagement. Asia Pacific Peoples Forum on Sustainable Development.

All the other ongoing programs have been able to achieve their objectives and could make considerable impact on the lives of the marginalized communities. The organization in partnership with TTC was able to muster support from USAID for a project "Organize, Implement, and Oversee the Smart Cities Competition amongst Universities in Rajasthan in Collaboration with US Universities" during the year.

I would like to thank all the well wishers, friends and partners of CECOEDECON for your continued support and guidance.

CECOEDECON's partner community member recognized in the UNFCCC Annual report

#### **Climate Champion Kota Bai**

Kota Bai Bheel has been an inspirational local development champion whose efforts have been instrumental in bringing about transformational change in the lives of the tribal village community of Purampur in Shahabad block of Rajasthan.

Despite facing numerous struggles as a young widow, through the motivation of CECOEDECON, she not only strived for the development of her own family but also emerged as a role model. Observing the struggles of the agriculture-dependent farming community, she decided to take action despite her meagre resources. She mobilized the farming community of her village in not just identifying the lack of availability of water as a major hurdle in local development but also led them in evolving low cost, community-based solutions to address the problem based on their traditional understanding of the local climate and flow of water. With the financial and technical backing of CECOEDECON, Kota Bai mobilized 25% contribution from the villagers (in the form of labour) in construction of a traditional water structure to check the runoff of rainwater and channelling it into her village.

The community benefited multifold from this low-cost solution through the impact on agricultural productivity. It also allowed the village community to innovate their irrigation practices. Moreover, the farming community has also been able to take two crops from their lands, increasing their livelihood avenues. The enhancement in local income generation opportunities has in turn reduced the dependence of the locals on migration. Understanding the importance of this initiative the locals have shown great commitment to its management and sustainability.

Her efforts as a climate and water champion have been recognized at various forums including the showcasing of her case study in the 2018 Annual Report of the United Nations Framework Convention on Climate Change.

#### **MISEREOR Visit**

Misereor, Germany is one of the long standing partners of CECOEDECON. Since 1987 Misereor has been supporting various development projects of CECOEDECON. Participatory Initiatives for Integrated Rural

Development (PIIRD) is one of the flagship programs of CECOEDECON which is supported by Misereor. Over the years Misereor has significantly contributed to the growth and development of CECOEDECON. In order to give a first hand knowledge and understanding on the various development initiatives of CECOEDECON, a team of ten Misereor supporters, mostly Senior Secondary School Teachers (some of them retired) along with three Misereor staff at Aachen, Germany (including the Programme Officer for Rajasthan Mr. Anselm Meyer-Antz) visited CECOEDECON on 22<sup>nd</sup> and 23<sup>rd</sup> October, 2019.



The visit included exchange of organizational

information, sharing of experiences; interactions with the Board members of CECOEDECON; meetings with the

core team members, field staff, representatives of Community Based Organizations such as the KSS, KSSM and representatives of Women Cooperatives. More time was spent in the field visiting Bapugaon village where the organization has taken up extensive soil and water conservation interventions with the effective participation of the village communities. The visit to the small check dam and the interaction with the farmers revealed not only the economic, social and environmental benefits which they derive because of the structure but also highlighted their collective efforts in mobilizing resources for maintaining and sustaining it over the years. The team was also given exposure to the integrated farming interventions (Smart Farms) practiced by the farmers in Badarwas village in Chaksu Block.

From the very beginning CECOEDECON has placed great emphasis on women empowerment initiatives starting with the formation of Self Help Groups and their Federations. The visitors were provided with an opportunity to interact with the members of a Self Help Group involved in a livelihood activity of 'garment making' and their marketing interventions. This was followed by an interaction with the members of Women Cooperative at Shilki Dungri branch office. This particular Women Co-operative is managed by women and has more than 25000 members. The loan portfolio of the cooperative has crossed Rs. 20 crore this year.

The visit was very fruitful and the feedback received from the visitors indicated that "It was a perfect visit".

#### Report card on SDGs:

CECOEDECON along with MAUSAM and partner organizations released the review report on Agriculture. The report was released on 17th March, 2020 at UNRC, New Delhi in the presence of Ms. Rasha Omar, Head, South Asia Hub, UNRC. The report, prepared according to SDGs framework, reflects upon challenges of the agriculture sector and the farming community. This report also presents good practices and recommendations

#### **Empanelment of CECOEDECON under CSIR NEERI**

As one of CSIR's premier institutes with a focus on the environment, NEERI plays a significant role in defining Leadership in Environmental Science and Engineering for Sustainable Development. Currently, the Institute, in line with the vision, mission and policy of CSIR, has delineated thrust areas for R&D consisting of I). Air Pollution Monitoring and Control, II). Water Technology and Management, III). Climate Change, Cleaner Technology and Modelling, IV). Energy and Resource Management, V). Environmental Biotechnology and Genomics, VI). CSIR-NEERI also aims to develop a robust environmental framework that promotes productive and sustainable use of natural resources. CSIR-NEERI have always been a front-runner in developing cost-effective, need-based and bio-inspired technological innovations suitable to socio-economic conditions prevailing in the country in a sustainable, inclusive and people-centred manner. NEERI significantly contributes towards policymaking, environmental regulations, and implementation through active participation in various National and State level expert committees constituted by Ministries and Regulatory agencies. To expand the activities and also to bring in issues of Grand Challenges which our country should address, CSIR-NEERI wanted to initiate a comprehensive programme for next two years with the help of good NGOs/NPOs..

After clearing a three stage approval process **CECOEDECON** has successfully been empanelled with CSIR-NEERI under the category Science for Women Empowerment at Gram Panchayat for Sustainable Living (SFW). CECOEDECON is one of the very few organizations empanelled with this renowned technical institute and is the only organization empanelled in this category in Rajasthan.

#### NETWORKING AND INTERNATIONAL ENGAGEMENTS

#### Introduction

Over the years CECOEDECON has established a strong engagement mechanism to actively take up the issues of the vulnerable and marginalized communities at the critical discussion and decision making platforms at national and international levels. Some of the major events where the organization participated to engage on critical issues having consequence for CECOEDECON's partner communities are described as under:

# United Nations Climate Change Conference (COP25) Madrid Spain from 2<sup>nd</sup> December 2019 to 13 December 2019.

The main expectations from the COP 25 was to finalize the Paris Agreement Rulebook by giving a shape to the market based and non market approaches, undertake review of WIM including finding a separate funding mechanism to compensate loss and damages, and decide timeframes for reporting on NDC in future. However, participants also expected that the overall effort of the COP should be to enhance the ambition of the countries especially in the light of ominous revelations in the recent IPCC reports including IPCC SR, report on land and special report on oceans and cryosphere. While failing to respond to the broader expectation on enhancing ambition; it also failed to come to agreement on how to resolve differences on the market and non market based mechanisms, and time frames. The review of WIM also failed to respond to the aspirations of developing countries and the LDCs and SIDS for separate funding mechanisms within Warsaw International Mechanism on loss and damage. The COP decided to work towards resolving differences through the year and take decisions in the next COP in the UK.

A delegation of the CECOEDECON & MAUSAM (Movement for Advancing Understanding on Sustainability and Mutuality) participated in the COP 25 held at Madrid from  $2^{nd}$  to  $13^{th}$  December, 2019. The delegation included Soumya Dutta, Ajay K Jha and Shyam Ladrecha. They engaged in a number of activities including side events, press conferences, solidarity activities, meetings with country delegations to follow negotiations on different tracks and represent the voices from the grassroots.

Ajay K Jha spoke on a side event organized by Ibon Foundation and others on 11<sup>th</sup> December, titled "Climate Justice Town Hall: People-Powered Climate Action: Reclaiming the Climate Agenda amid Corporate Plunder and Repression."

CECOEDECON and MAUSAM also organized a PRECOP Consultation in Delhi on 28<sup>th</sup> November to discuss the important issues, priorities and possibilities in COP 25, which received representation from Embassy of Chile in New Delhi

# Participation in ASEAN People's Forum/ ASEAN Civil Society Conference (10-12 Sept. 2019) and Regional Training of Trainers on Advocacy and Engagement (13–14 Sept. 2019) in Bangkok

ASEAN People's Forum/ASEAN Civil Society Conference (APF/ACSC) was organized at Bangkok, Thailand from 10<sup>th</sup> to 12<sup>th</sup> September 2019. The theme for this year's ASEAN People's Forum was Advancing People's Movements for Justice, Peace, Equality, Sustainability and Democracy in Southeast Asia. Civil society organizations in Southeast Asia have been engaging with ASEAN member governments over a number of platforms. One of the engagement modalities is the annual APF/ACSC, held in parallel



with the now bi-annual ASEAN Summit of Leaders, with the key aims at knowledge sharing and exchanging among people of Southeast Asia region and delivering peoples recommendations to ASEAN Leaders.

For the year 2019, Thailand was the chair for ASEAN summit and Thai CSOs has hosted the APF. More than 1000 participants from different NGOs, CSOs, and community groups from 11 ASEAN Countries and other countries and students from Thai universities took part in this three days event. Ms. Ritu Tiwari from CECOEDECON participated in this event as an APRN network member.

Different issues related to the situation of justice, peace, equality, democracy and sustainability were discussed. During the opening ceremony, a plenary



session was organized on ASEAN responses to peace, equality, sustainability and democracy in Southeast Asia and their responses to challenges associated in these fields.

Regional Training of Trainers (ToT) on Advocacy and Engagement was organized by APRN at Bangkok on 13-14 Sept. 2019. This training was a part of a regional project funded by European Commission. The training was attended by 25 participants from different countries like India, Bangladesh, Nepal, Philippines, Indonesia, Thailand, Bahrain, Kyrgyzstan, Mongolia, Hong Kong, etc. Mr. Antonio Tujan Jr from IBON International was the trainer for this two days training. This was the first part of the training. The second part of the training was organized in November 2019 which was also attended by Ms. Ritu Tiwari along with APF.

#### THEMATIC AREAS AND PROGRAMS

CECOEDECON's work centres around three broad thematic areas which evolved over the years as a response to changing needs and context that impact the poor and the marginalized.

The section below describes the themes and specific focus areas in brief:

Participatory Initiatives for Integrated Rural Development (PIIRD) is a longstanding intervention of the organization aimed at enhancing lives and livelihoods of the poor and the marginalized. Focusing on themes viz economic justice & livelihood security, Basic Rights. The program adopts civil society building and institutional development as its cross cutting strategies. Details of the key initiatives under the project are as below:

#### LIVELIHOOD SECURITY AND ECONOMIC JUSTICE

"To build climate change adaptation capacity of stakeholders while simultaneously securing the sustainability of livelihoods of the poor and the marginalized."

Agriculture is the mainstay of Indian economy and provides food and livelihood security to a substantial section of the Indian population. The impact of climate change as witnessed in recent times has immense potential to adversely affect agriculture in many ways. Climate change is experienced against a background of other global changes such as population growth, urbanization, land use changes and depletion of freshwater resources that themselves have implications for health and which can, in some cases, interact with climate change to magnify the impacts. We have witnessed how the impacts of these changes are hitting the poorest hardest, exacerbating existing environmental problems, stretching coping capacities and challenging achievement of the SDGs.

#### **ANNUAL REPORT 2019-20**

In recent years, land-based livelihoods of small and marginal farmers are increasingly becoming unsustainable. As a result, rural households are forced to look at alternative means for supplementing their livelihoods. In this context, natural resource-based micro-enterprises have emerged as alternative livelihood opportunities in rural areas. Varying socio- economic and environmental trends including declining crop prices, migration and urbanization increased the demand for alternative employment and off farm livelihood opportunities. The usage of chemical pesticides and fertilizers for enhancing crop produce, however, is still rampant even with stakeholders perceiving a reduction in soil quality and increase in soil hardness with no alternatives available. Migration, in some cases, also increases sensitivity which is a reluctant choice.

Recognizing the need for improving the food and livelihood security of the small and marginal farmers, the economic justices and Livelihood security theme focussed on the following initiatives:

#### Development of Adaptation plans at Panchayat level and their implementation

In order to develop the panchayat level adaptation plans, risk vulnerability assessment was done in all the villages of selected gram panchayats in each block. Community members and representatives of the Community Based Organisations were actively involved in the risk and vulnerability analysis. Different Government Programmes and schemes were identified for convergence under the adaptation action planning. These plans were then submitted to respective gram panchayats, during gram sabhas to get their approval and incorporation in gram panchayat level development plan.

The adaptation plans developed were incorporated into the gram panchayat level development plans in Phagi, Chaksu and Newai blocks. Some of the adaptation plans included construction of soak pits for collection of waste water, plantation on pasture land, development of Kitchen gardens, construction of water conservation structures, pond digging, well recharge, construction of farm ponds etc.

#### Preparation of People's Biodiversity Register-

Climate change has a major impact on biodiversity of the area. To protect and conserve the biodiversity, the government has enacted Biodiversity Conservation Act and according to this act a people's biodiversity register needs to be developed and maintained at each gram panchayat level. People's Biodiversity Registers are developed in Khanddevat gram panchayat Newai block, Sindholiya gram Panchayat of Malpura block, and Sanwad gram panchayat of Shahbad block. Village level meetings of community people were organized in each village of gram panchayat. In these meetings community representatives who have some indigenous and traditional knowledge were mainly involved. This register was mainly based on local knowledge available in the area. As biodiversity loss has a direct impact on food and seed sovereignty of the area therefore documentation of available food, seed and plant varieties was mainly focused during the preparation of the People's Biodiversity Register. Major food, seed and plant varieties were not only documented but efforts to collect their sample were also made.

#### Demonstration on improved agricultural practices-

Organic farming is promoted through a combination of crop management options such as water management, mulching, crop rotation, diversified cropping (including agro-horticulture, fodder crops and indigenous drought resistant varieties), vermi-composting, crop residue recycling, pest management and seed banks. Total 230 Demonstrations were given on different improved agricultural practices like establishing integrated farming models, composting/vermi-composting, development of ago horticulture models and kitchen gardening, etc.



Support from different government schemes to improve climate resilient agricultural practices were also provided. These activities have helped the community to practice organic farming and also secure their long term food security.

#### Facilitating support from different government schemes -

There are few government schemes like RKVY, NREGA etc. available for farmers to motivate them to adopt climate resilient agricultural practices like support for construction of farm ponds, farm field bunding, greenhouse and poly house etc. In order to link poor from the local communities to relevant schemes and programs of the government, facilitation centers are being run in Chaksu and Shahbad blocks. The centers aim to provide information and support members of the local community in accessing the benefits of different livelihood support and welfare schemes. As a result of this facilitation support, 1533 people availed the benefits under different government schemes like construction of farm ponds, vermicompost, sprinklers set for irrigation, solar pump and mini kits of seeds for different crops, improved seeds of wheat and gram, NREGA and agricultural insurance, etc.

#### **Skill Building Trainings-**


A skill building centre was inaugurated in the Shahabad campus of the organization. The centre constructed with the support of the Japan embassy has been named after the founder of the organization Mr. Sharad Joshi to remember his contribution in the development sector.

Under the project, 4 different skill trainings – Electrician, Fitter, Welding techniques and computer skills were proposed for young boys and girls and training on food processing were proposed for rural women.

After the formal inauguration of the skill building center, the course curriculum was designed for training on computer skills and electrician for young girls and boys. The computer training also got affiliation from Rajasthan Knowledge Corporation Limited (RKCL) for the course of Rajasthan State Certificate of Information Technology (RS-CIT). This course is high in demand and a mandatory requirement to apply for any government jobs. First batch of 120 students were enrolled and attended 3 months training on information technology skills.

43 women and girls also attended 3 months training on information technology skills under Indira Mahila Shakti Training and Skill Development Scheme of Department of Women and Child Development.

Similarly, the course curriculum was designed for training to work as an electrician and trainer was identified. A 90 days long skill building training for youth has been organized to work as an Electrician. This was the first batch of the 70 youth who have received training in the newly constructed skill building center. The skill building training curriculum included both the theoretical and practical knowledge. Along with theoretical knowledge of working as an electrician, youth were also given the opportunity to do it practically.




#### Training of women on food processing and packaging-

70 girls were trained on food processing techniques. The course curriculum was designed based on local needs and locally available food items. The participants were trained on techniques related to sorting, drying, grinding and making different food items that are consumed in nearby markets. Locally available items like mango, gooseberries, guava etc, were used for further processing and candies, pickle and jam were made from these products.


#### Microfinance and Financial Inclusion:

The Microfinance program of CECOEDECON was started in the year 1996 with the objective of providing easy access to credit to rural women who are economically and socially marginalized. Following a community organization process, the village women were organized into Self Help groups, enhancing their capacities and facilitating saving among them by opening group accounts in banks. Eventually, the large base of SHG's called for a higher level of organization and systematic management which led to the formation of Cooperatives. These Multipurpose Cooperative Societies are actively working to ensure financial inclusion, financial literacy, access to credit, and livelihood security and sustainability for the partner community. These efforts have brought about significant changes in the status of the member women, by not just making them financially secure but also contributing to their empowerment and overall development.

#### Progress made under National Urban Livelihood Mission, Madhya Pradesh

CECOEDECON is working for the welfare of the urban poor in Indore Cluster of Madhya Pradesh under the National Urban Livelihood Mission. The project is being implemented in Indore, Dhar and Burhanpur with the objective to secure and enhance the present livelihoods and coping strategies by mitigating risks; promoting income and employment enhancing opportunities by building capacities and providing financial services; and promoting inclusion, by empowering and organizing the target households into SHGs, federations.

#### **BASIC RIGHTS**

"To consolidate the ongoing empowerment processes and further strengthen the community based mechanisms that support rights based entitlements of the most excluded communities."

The rural communities face challenges stemming from low literacy, lack of awareness about rights-based entitlements and access to quality education and health services in remote areas which, when coupled with stringent socio-economic factors, greatly hamper their development potential. CECOEDECON through its Basic Rights program works on providing support and solutions to these problems. The program also takes steps to strengthen democratic institutions and forums at the local level, supporting community, women and children in addressing injustice and providing methods for ensuring inclusive, rights-centric development by being gender sensitive.

Under the Basic Rights theme Gender, Child Rights and Health issues were taken up in five blocks: Chaksu, Phagi (Jaipur) Newai, Malpura (Tonk) and Shahbad (Baran).

Village level institutions and the Kisan Seva Samiti have continually been working on education, health and gender development and have participated in local governance to address the issues of basic rights.

The Preparation of Annual Gram Panchayat Development Plan through gender responsive planning and gender mainstreaming was focussed during the year. Five batches of capacity building of youth federation on gender responsive planning were undertaken with a total participation of 139 youth both male and female. They mapped out the gender issues in the villages and planned a strategy to address the issues. Five workshops with CBOs on mainstreaming gender concerns were organised in which 119 males and 95 females participated. These workshops helped to strengthen the role of women in taking up various issues through the CBOs and other democratic institutions.

Two orientations on Gram Panchayat Development Plan (GPDP) were organised at Malpura block in four Gram Panchayats. Total 77 female and 82 male participants attended the orientation, including elected representatives.

#### Residential School for Tribal Girls in Shahbad

Realising the significance of the right of children for free and compulsory education (Right to Education Act 2009) Cecoedecon has initiated a residential centre for tribal girls in Shahabad block of Baran district. Poor girls who have not been able to pursue their education because of academic, economic or social reasons are provided

with an opportunity to continue their education through this residential school, where free lodging & boarding along with special coaching is provided. 53 girls including girls from the most primitive tribes of Shaharia could avail the opportunity and could appear for the State Open Board Examination.

#### **Ensuring Education and Health Services**

The Community Based Organisations have taken serious efforts to make sure that the children enrolled are provided with quality education and health care services by regularly visiting the schools and health care centres. Their interaction with the service providers have helped in solving many of the problems related to these services. They were also instrumental in activating the village and Panchayat level committees such as the School Management Committees (SMC), Village Child Protection Committees (VCPC), Village Health Nutrition and Sanitation Committees (VHNSC) and the Bal Sabhas.

#### **CASH Meetings**

Two meetings of Committee Against Sexual Harassment (CASH) were organised to address the issue of sexual harassment at workplace. Organisation has been a part of other internal complaint committees and participated in their meetings regularly. An orientation for 'Akashwani' staff on the issue was also organised during the year.



#### **Empowering Elected Women Representatives of Gram Panchayats**

With the support of The Hunger Project, CECOEDECON has been implementing this project for the last 20 years. The project interventions have been undertaken in Chaksu, Shahbad and Newai blocks of Rajasthan. Main objective of the project is to mobilize and strengthen the elected women representatives of Gram Panchayat for good governance. During the year five need based capacity building workshops were organized to enhance the skills and understanding of Elected Women Representatives on various issues and various programs and schemes of the government and on their roles as members of the local governance. Elected Women Representatives' block level federation meetings were also conducted regularly during the reporting period.

#### **Rakshan Project**

Project Rakshan is being implemented in 20 villages of Malpura block of Tonk district. It is a 3-year program intervening to provide safe spaces conducive to the development of children of the local community. The project is also aimed at enhancing the livelihood security of women and youth and belonging to communities which are vulnerable to trafficking.

#### Major Activities include:

Regular meetings of the Bal Panchayats, youth and SHGs



- Enrolment of dropped out children and prepare them for State Open Board Exams
- Providing Scholarship to Students for education
- Imparting of capacity building trainings to village level institutions and mobilizers

- Two livelihood centres continued to provide livelihood support to women
- Activating of School Management Committees, and Village Child Protection Committees
- Organization of village level health camps focusing on reproductive health issues
- Celebration of Children' Day, Women' day at block level.

#### INSTITUTIONAL DEVELOPMENT

"To provide facilitation and support to the Apex institutions in sustaining village level institution development processes and further strengthening the village level institutions such as Panchayats, VDCs, youth groups and Women groups, to enhance their active participation in climate change adaptation measures that would secure sustainable livelihood of poor and the marginalized."


CECOEDECON has promoted over 600 Village Development Committees and other village level Community Based Organization which have been federated into Kisan Sewa Samitis at 5 blocks and Kisan Sewa Samiti Mahasangh at the state level to take up the concerns of the people at the relevant platforms.

The Institutional Development Program looks to provide facilitation and support to the Apex institutions in sustaining village level institution development processes and further strengthening the village level institutions such as Panchayats, VDCs, youth groups and women's groups to enhance their active participation in rights-based economic development and climate change adaptation measures that would secure sustainable livelihood of poor and the marginalized.

#### Strengthening of community institutions:-

The following efforts have been undertaken during the reporting year:

- Regular meetings of CBOs took place both at village and block level with their active participation.
- Various developmental issues related to food security, livelihood, health, education, drinking water, electricity etc. were identified and addressed at the appropriate platforms.
- VDC, KSS and KSSM are regularly monitoring the implementation of schemes like MGNREGS, food security schemes (PDS/TPDS), crop and livestock insurance, Mid Day Meal Scheme, Functioning of Aaganwadi centres and functioning of other statutory democratic bodie.
- CBOs have actively participated in the process of GPDP at panchayat level and issues identified by the community have been included in the Panchayat Development Plan. Now they are engaged in the follow up of the implementation of the plan.



Issues and concerns raised during these meetings were related to establishment of procurement centers, ensuring purchase of crops on minimum support price, high tariff rates of electricity, crop compensation due to hailstorm, regularizing water supply, regularising Aanganwadi centers, timely payment under MGNREGA and ensuring food security of the needy and marginalized communities.

CBOs have been actively involved in mobilizing support at various levels. **Following are some of the KEY achievements:** 





#### **Training of Apex Institutions**

CECOEDECON has developed a number of institutions since its inception. Various capacity building efforts were taken by the organization to strengthen and sustain these institutions. Ensuring the sustainability of community based institutions requires continuous efforts. There is a need to enhance the skills of institutions related to resource mobilization, taking independent actions, developing potential leaders, communication and documentation etc. in the present context to ensure their long term sustainability. A two days training of Apex institution was organized. KSS/M, Block Youth Federation and Cooperative representatives joined the training. Experts of Livelihood, climate change, organizational development, panchayati raj and gender facilitated different sessions.

#### Youth Sammelan: -

A two days long youth consultation was organized with the objective to develop such a learning platform for all youth groups where they could interact, share their experiences and get motivated to work as change makers through active involvement in development processes at local level.

#### **Exposure Visit of Farmers:-**

Every year Members of Kisan Sewa Samiti (KSS) visit such Organization/Institution who are



contributing towards the development of society in an innovative way. This exposure provides them a platform to exchange experience and gives a learning opportunity to understand various developmental issues. This year a group of 50 KSS members went to Faizabad to visit PANI, a voluntary organization working in Uttar Pradesh. Farmers visited the field area of PANI and learnt about the MACHAAN KHETI and local methods of water conservation.

#### Monitoring of implementation of different government schemes and programs-

CBOs play an important role in ensuring effective implementation of different government schemes and programs at village, panchayat, block and state level. CBOs are not only monitoring but also supporting the implementation of a number of programs and schemes while ensuring its wider outreach.

CBOs continued their efforts for effective implementation, proper targeting and monitoring of different schemes and programs during the reporting period. They have been continuously monitoring the implementation of schemes like PDS, MGNREGS, Social security schemes and schemes related to agriculture improvement, etc. They were also involved in ensuring proper functioning of AWC, health and education facilities at village and gram panchayat level.

#### District level consultation-

A District level consultation was organized in Shahbad on 16th March, 2020 with different service providers to facilitate better access and quality of services for furthering the progress on SDGs and ensuring basic rights, livelihood and food security of the partner communities at large. Around 70 participants including CBOs and PRI members participated in the consultation. Government officials from different departments like-Health, Education, ICDS, NREGA, Agriculture took sessions and discussed various schemes and programs. Participants also asked their queries and problems to the concerning officer.

#### CIVIL SOCIETY BUILDING

"To facilitate the process of enabling environment for CSOs and CBOs towards advocating sustainable development with specific focus on integrated approach on climate change."

Civil society plays an important role in supporting the implementation and monitoring of the different aspects of policies and schemes of government. It speaks for the ground-level community and acts as a bridge between the government and people's voices. Realizing the importance of building common voices and collaborative efforts, CECOEDECON has taken up Civil Society Building as a key strategy.

The organization held several events at National and International level under the organization's objective for Civil Society Building (as briefly mentioned in earlier sections). Best examples and practices based on the organization's grassroots experience were also shared through participation at district, state and national level. Some of these include:

#### Planning workshop with stakeholders:

A two day's planning workshop was organized with NGOs and community based organizations on 21-22 June, 2019 at SWARAJ campus, Jaipur. The objective of the workshop was to develop an understanding on Sustainable Development Goals and after identifying priority goals, prepare an action plan for the next two years.



# Discussion with media on developmental issues:

CECOEDECON organized a dialogue with the media on various developmental issues on 3rd of May. In the presence of senior journalists; Shri Om Thanvi, Vice Chancellor, Haridev Joshi University of Journalism delivered the keynote address, covering various emerging issues. He emphasized the need to sensitize people on climate change and the role media can play.

#### Regional consultations on Sustainable Development Goals (SDGs):

CECOEDECON organized three regional consultations on Sustainable Development Goals (SDGs) at Bharatpur (26th August), Jhunjhunu (19th September) and Kota (2nd December) with NGOs and media representatives. Around 50 participants from various organizations participated in each consultation.

#### Meeting of State Level Forum on SDGs:

The SDG forum was initiated to create a constructive platform for generating awareness among civil society and also analyzing the progress of the state government on Sustainable Development Goals. Meeting of Executive committee of state level forum on SDGs was organized on 29th July, 2019 at SWARAJ campus, Jaipur in the presence of Ms Aparna Sahay, Dr. Kshipra Mathur, Dr Nesar Ahmad, Mr. Gopal Verma, Ms Vibhuti Joshi and Dr Alok Vyas.

#### UNCCD Pre-CoP-14 at Jaisalmer:

India hosted the UNCCD CoP 14 where 9000 participants from all over the world took part. The Conference adopted the Delhi Declaration in which parties expressed commitment for a range of issues, including gender and health, ecosystem restoration, taking action on climate change, private sector engagement, Peace Forest Initiative and recovery of five million hectares of degraded land in

India.

In the run up to the UNCCD CoP, CECOEDECON along with MAUSAM organized Pre CoP 14 at Jaisalmer on 28th of August to discuss the issues and challenges of land degradation due to climate crises. Participants from various organizations and institutions shared their experiences related to desertification and land degradation in the western region of Rajasthan.



A small delegation from CECOEDECON participated in the official event in Delhi to understand the issues being faced in other countries and network with other organizations to learn about best practices and other trends.

#### **National Consultation with Farmers:**

CECOEDECON along with PAIRVI, MAUSAM, ASHA and Kisan Sewa Samiti Mahasangh (KSSM) organized a

National Consultation with farmers. The consultation was a part of "Leave No One Behind" Consultations towards the preparation of India's Voluntary National Report 2020 (VNR 2020), to be presented in the UN's High Level Political Forum in July 2020. Around 200 farmers and development organizations from Rajasthan, MP, UP, Orissa, Telangana, Maharashtra, Haryana, Karnataka and Delhi participated in the consultation. UN resident coordinator Ms Renata and Mr



Soumya Guha, representative of NITI Ayog inaugurated the consultation. The focus of the consultation was to identify challenges and vulnerabilities of often-left-behind farmers, ie., rainfed farmers, women farmers, tenant farmers, landless farmers, livestock farmers and pastoralists and adivasi farmers. All sessions were concluded with actionable recommendations and suggestions.

#### OTHER ONGOING PROJECTS

Facilitating Integrated Programme Delivery in Sawai Madhopur, Udaipur and Jaisalmer districts through systems strengthening for improved outreach in addressing needs of young people, women and girls.

In order to meet the reproductive health needs of the young people and for facilitating empowerment of young girls, different programs are being implemented by both central and state Governments including RKSK, MPV, SABLA and BBBP. Besides that state govt. has launched state strategic action plan for prevention of child marriage in the state.

UNFPA initiated the program with CECOEDECON in three districts Sawai Madhopur, Udaipur and Jaisalmer in Rajasthan to strengthen the health system and service delivery with particular focus on young people/adolescents through capacity building, mentoring, activating different institutional mechanisms and facilitating the use of data for decision making to improve the services.

During the year 2019, various strategic interventions undertaken under these sector programmes include mentoring, development of model processes (Girl Friendly Gram Panchayats) capacity building of various health officials & front line workers, community based panchayats interventions, support for campaigns, convergence meetings, establishment of district resource centre etc. These have significantly contributed in enhancing the quality of Reproductive Health Services to young people, preventing violence and empowering girls.

#### Jaipur Child Development Project\_Tapukra (Alwar) & Pachkodiya (Jaipur)-

CECOEDECON in partnership with ChildFund India has launched a project Jaipur Child Development Program in 20 villages in Sambhar Lake block of Jaipur district & 13 villages in Tijara block of Alwar district.

From April, 2019 branch offices at Pachkodiya (Jaipur) and Tapukara (Alwar) were established and necessary staff members required were appointed.

Key interventions included the following: -

- Sponsorship activities with 874 children
- Work on child development issues with enrolled children in the age group 6-24 years as well as with non sponsored children.
- Child right sensitization activities with parents, community, Govt. officials and other stakeholders



#### Engagement for Women Empowerment and Livelihood Initiative, Gadepan

CECOEDECON is working in partnership with Chambal Fertilizers and Chemicals under the Community Livelihood Project, The program aims at supporting livelihood enhancement needs of communities living in 8 villages nearby Gadepan (Kota). Specific inputs beingprovided to the communities include access to safe water and sanitation facilities, training for agriculture and horticulture, animal health, promoting self help groups (SHGs) and institutional building. Besides, the project has also been instrumental in rganizing groups of adolescent girls and providing them training in life skill areas.

To consolidate the efforts of the Self Help Group promoted through the project, they have been organized into a

cooperative. The registration of Women Cooperative has been completedFormation of Farmer producer organization is in process.

#### **CECOEDECON Jaisalmer**

CECOEDECON has been working in the Jaisalmer district since 2008, the organization is working in the district in partnership with following CSR initiatives:

- Project –SRIJAN in partnership with SUZLON foundation in 36 villages
- Project SUCCESS with SUZLON foundation and China Light & Power (CLP), India in 3 villages

#### **Key Areas of Work:**

- Community mobilization and CBOs formation and strengthening in 39 villages
- Strengthening of block level Kisan Seva Samiti
- Livelihood enhancement through various interventions such as animal health/ vaccination camps, water harvesting structures, vocational training to women groups, etc.
- Quality Education through supply of materials such as furniture, sports items etc. in schools
- Clean drinking water availability through tank construction
- Natural resource management through pastureland development
- Sanitation in schools and villages
- Eye screening camps



During the reporting year over 200 cases have been covered by the project. Details of the nature of calls during the project is as below:



The broader objectives of the IEC Activities are to facilitate community participation and involvement at village level in the planning, implementation and management of water supply to assure sustainability of the project.



#### SATELLITE INSTITUTIONS

To address issue-specific areas more effectively, CECOEDECON has established off-shoots to its core work areas to move beyond existing interventions:



- MAUSAM- Movement for Action and Understanding on Sustainability and Mutuality, This pan-Indian coalition of 40-plus organizations addresses emerging issues of climate and environmental justice, energy equity, sustainable development and post-2015 development. It engages with various stakeholders at multiple levels, to bring about desired change or the welfare of the people
- **DCNC Development Coordination Network Committee Trust**, a state-level network of NGOs working in Rajasthan.
- PAIRVI Public Advocacy Initiatives for Rights and Values in India, New Delhi, an advocacy support center that caters to capacity building needs of social advocates working in ten states in north-central India.
- **CDHR Centre for Dalit Human Rights,** an information and support centre on Dalit issues. With focus in Rajasthan, it intends to work with Dalit groups in other north-Indian states as well.
- JP Jal Prahari, a specialized network working on water issues in Rajasthan.
- **Block-level Women' SHG Federations**, apex institutions of village-level Self Help Groups across five blocks of Jaipur, Tonk and Baran districts that have been federated to promote economic empowerment of women.
- **SWARAJ Social Work Academy for Research and Action, Jaipur,** an initiative committed to develop appropriate human resources or the social development sector by undertaking knowledge management, training, education and research activities.


